A RESOLUTION SUSPENDING THE APRIL 1, 2018, ANNUAL THREE PERCENT (3%) INCREASE FOR WATER AND SANITARY SEWER SERVICES IN CHAPTERS 1050 AND 1060 OF THE CITY OF PICKERINGTON CODIFIED ORDINANCES

WHEREAS, the City of Pickerington has established an automatic rate increase of (3%) every year effective on April 1st of each year for water and sewer services; and

WHEREAS, City Council desires to suspend the increase that would go into effect on April 1, 2018, and

WHEREAS, the water and sewer fees must be adopted by City Council.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PICKERINGTON, FAIRFIELD-FRANKLIN COUNTIES OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

Section 1. Council hereby suspends the annual three percent (3%) increase for water and sewer rates that would take effect April 1, 2018, and to maintain the water and sewer rates reflected in Exhibit "A" until it is determined the increase is necessary.

Section 2. This Resolution shall take effect and be in force from and after the earliest date permitted by law.

Water and sewer rates for 2018

<u>Service Charge</u> – A minimum service charge based on meter size is hereby established as follows:

Water Metered Rate – The charge for all metered water used is hereby established as follows:

There shall be a ten percent (10%) surcharge on the metered rate set forth herein for all customers outside the corporation limits.

<u>Sewer Rates</u> – There is hereby established a sewer service charge for the use of and for the service made available by the Municipal sanitary sewer system, which charge shall be based upon the amount of waste flow into the Municipal sewer system, whether from within or without the Municipality, according to the following schedule:

<u>Utility deposit fee</u> – To establish service there shall be a \$100.00 deposit fee for all renters.

<u>Water shut-off reconnection fee</u> – There shall be a \$50.00 reconnection fee charged for all water shut off due to non-payment.

<u>Water meter test</u> – To test a ¾ inch meter the charge shall be \$25.00, meters larger than ¾ inches the charge shall be cost of labor to remove the meter and cost of the test.

Water meter purchase – City cost plus 20%

Water line inspection - \$40.00 per inspection

Sewer line inspection - \$40.00 per inspection
