DAYS**

**WHEREAS**, the Mayor proposes the attached addendum to the Acting City Manager's employment agreement for Council's approval of the employment of Acting City Manager Frank Wiseman, as required by the Charter;

**WHEREAS**, Council finds it is in the best interest of the City to approve the execution of this addendum to allow the Mayor and Acting City Manager to negotiate the terms for a longer term agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF PICKERINGTON, FAIRFIELD-FRANKLIN COUNTIES,  
OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:**

**Section 1:** The Pickerington City Council hereby concurs in the Mayor's appointment of Frank Wiseman as Pickerington's Acting City Manager and authorizes the Mayor to execute the attached Addendum to the Employment Agreement for his services as City Manager for an additional (60) days term to allow the Mayor and Acting City Manager to negotiate a longer term agreement as City Manager

**ADDENDUM TO THE ACTING CITY MANAGER'S  
EMPLOYMENT AGREEMENT**

THIS ADDENDUM TO THE EMPLOYMENT AGREEMENT ("Addendum"), is made and entered into this 17 day of July, 2018, by and between the CITY OF PICKERINGTON, Ohio, an Ohio municipal corporation, ("Employer or City") and FRANK WISEMAN, ("Employee or Acting City Manager").

**WITNESSETH**

**WHEREAS**, Section 4.05 of the City Charter provides the Mayor with the right to appoint an Acting City Manager for up to sixty (60) days, without the concurrence of Council; and

**WHEREAS**, Section 4.05 of the City Charter further provides the Mayor with the right to appoint an Acting City Manager for beyond sixty (60) days only with the concurrence of Council; and

**WHEREAS**, it is the desire of the Mayor, with concurrence of City Council, to enter into an addendum to employment agreement ("Agreement"), passed via Resolution 2018-14R with the Acting City Manager to extend the term as stated herein.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained, the parties agree the following term shall replace "Section 2: Term. A." of the Agreement:

**SECTION 2: TERM**

- A. The term of employment of this Agreement shall start on August 3, 2018 and end on the earlier of October 2, 2018 or when the Mayor appoints with concurrence of Council a permanent City Manager.

All other terms contained in the Agreement shall remain the same and have the same force and effect.

**IN WITNESS WHEREOF**, the City of Pickerington has caused this Addendum to be signed and executed in its behalf by its Mayor and duly attested by its Clerk of Council, and the City Manager has signed and executed this Addendum, the day and year first written above.
